Requirements for the Design of the Theses:

1. The volume of abstracts - up to 3 pages (format - page A4)
2. Fields: upper, lower, left, right - 2 cm. Paragraph indent 1.25 cm.
3. The output and the main text of the abstract should be in the font: Times New Roman, 14 pt., line spacing - 1.0.
4. **The UDC (in bold)** is placed in the left corner of the sheet. The next line contains the *Author's name (s) in bold, italics* in the upper right half of the page. Below (on the right) in the usual font in the following order: level of education, specialty; name of the educational institution; name of the city, country. Information about the scientific supervisor should be indicated below: «*Scientific supervisor*» - italics; below in normal font - surname and first name, academic degree and academic title, even below - the position in full. One line below is the **TITLE OF THESIS** – in capital letters, bold, centered.
5. Formulas should be executed in the formula editor, the drawings are grouped.
6. The title «**Literature**»: - center, in usual letters, bold, Times New Roman, 12 pt. The list of references is made out in the font: Times New Roman, 12 pt., line spacing - 1.0, numbered list, indentation 1.0 cm. Literature is presented in the original language, organized in alphabetical order of authors' surnames or titles, according to current standards. Literature for abstracts submitted in Ukrainian language is made according to the rules of the standards of Ukraine (State standard of Ukraine 8302:2015). References for abstracts submitted in English are made according to the requirements of the standard **APA** (American Psychological Association (APA) Style). 7. Number of authors - no more than two persons.
8. When writing theses, please adhere to the principles of academic integrity. Theses will be checked for textual borrowings. *The name of the abstract file* must include the name of the *first* author and the number of the section (for example, Ivanov_1_abstract).
